THE ORGANIZATION PLACES FOR ADOPTION ABANDONED AND UNWANTED PETS WITH THE HELP OF APPROXIMATELY 250 VOLUNTEER FOSTER HOMES AND HAS IN ITS PROGRAM 100 - 150 ANIMALS AVAILABLE ON ANY GIVEN DAY. THE FOCUS OF THE ADOPTION PROGRAM IS TO PROVIDE HOMELESS PETS IN OKLAHOMA WITH THE NECESSARY MEDICAL AND NUTRITIONAL CARE NEEDED AS WELL AS IN-HOME TRAINING AND BEHAVIORAL EVALUATIONS.
